**INTRODUCTION BY SENATOR JESSE HELMS, CHAIRMAN,  
SENATE COMMITTEE ON FOREIGN RELATIONS**

During the 106th Congress, the Committee on Foreign Relations approved authorization legislation for most programs falling within the Committee's jurisdiction, considered far-reaching legislation on United Nations reform, and reported several important bilateral and multilateral treaties.

In the second session of the 106th Congress, the Committee reported legislation, ultimately added to Foreign Operations authorization legislation, linking accountability, transparency, anti-corruption, and borrower-graduation requirements for the multilateral development banks to the authorization for Third World debt relief. The Committee also reported legislation to provide global AIDS and Tuberculosis relief, and legislation promoting micro-enterprise.

In a provision of the Admiral James W. Nance and Meg Donovan Foreign Relations Authorization Act FY2000-2001 (P.L.106-113), coauthored by Senators Helms and Biden, payment of U.S. arrears to the United Nations was tied to broad reforms. The first phase of P.L. 106-113 conditions—related to U.S. sovereignty—were met in November 1999, thus permitting the release of \$100 million in arrears. U.N. negotiations to reform general and peacekeeping assessment scales, which were concluded in December 2000, largely satisfied the second phase of conditions by reducing U.S. dues.

The Committee approved resolutions of ratification for a substantial number of bilateral and multilateral treaties, including the Hague Convention on Inter-Country Adoption. Following hearings on the Comprehensive Test Ban Treaty (CTBT), the Committee was discharged of further consideration of that treaty, which was rejected by the Senate in October, 1999. The Committee also gave priority attention to a substantial number of pending law enforce-

ment and investment treaties. The Committee reported bilateral extradition and mutual legal assistance treaties, as well as treaties providing for the return of stolen vehicles and aircraft. In addition, the Committee reported bilateral investment treaties and a maritime boundary agreement with Mexico. Multilateral agreements reported included the Hague Convention on Inter-Country Adoption, for which implementing legislation was also approved. The Committee also reported an inter-American convention on prisoner transfers, and an inter-American convention to prevent and punish corruption, among others. With the exception of the CTBT, the Senate approved all treaties that reached the floor during the 106th Congress.

Oversight hearings were numerous and productive. Perhaps the most significant hearing during the 106th Congress was the Full Committee field hearing on implementation of United Nations reform chaired by Senator Helms in New York on January 21, 2000. The Committee also held oversight hearings on U.S. foreign policy with Secretary of State Madeleine Albright, and on topics including the Anti-Ballistic Missile Treaty, the direction of treaty negotiations on conventional forces in Europe, national missile defense, U.S. embassy security, broadcasting, exchange programs, U.S.-Taiwan relations, inter-country adoption, the CTBT, the International Criminal Court, Iraq, reform of the IMF and World Bank, the Kyoto Protocol to the United Nations Framework Convention on Climate Change, the U.S. embargo against the Communist regime in Cuba, sanctions policy, the Fujimori Government in Peru, U.S. policy in Africa, U.S. China policy (including permanent normalization of trade relations), corruption in Russia, and Gore-Chernomyrdin agreements concerning Russian arms sales to Iran.

## 2. OTHER TREATIES CONSIDERED BY THE COMMITTEE

The Committee on Foreign Relations, pursuant to a unanimous consent order agreed to October 1, 1999, was discharged from further consideration of the Comprehensive Nuclear Test-Ban Treaty (Treaty Doc. 105-28). The treaty was placed on the Senate's Executive Calendar on October 6, 1999. The treaty was considered by the Senate on October 8 and 12, 1999. On October 13, 1999, the Senate voted to reject the resolution of ratification by a vote of 48-51, with one voting Present.



## 3. TREATIES RETURNED TO THE PRESIDENT

On October 12, 2000, S. Res. 267 was agreed to by the Senate directing the return of certain treaties to the President. Some of these treaties had been pending on the Committee's calendar for several decades. In all, seventeen treaties were returned as follows:

#### 1. DEPARTMENT OF STATE

There were 20 nominations for State Department officials referred to the Committee, of which 15 were confirmed by the Senate. These nominations were for Under Secretaries (4), Assistant Secretaries (12), Ambassadors at Large (2), Director General of the Foreign Service and one nomination for the personal rank of Career Ambassador.

## 2. AMBASSADORS

During the 106th Congress, 94 nominations for country Ambassadors were referred to the Committee. Of these 94 nominations, 76 were confirmed by the Senate, and two were withdrawn by the President.

In addition, the Committee received 20 nominations for the rank of Ambassador while serving in the following positions: U.S. Representative to the United Nations; Deputy U.S. Representative to the United Nations; U.S. Representative to the United Nations for U.N. Management and Reform; U.S. Representative to the European Office of the United Nations; U.S. Representative to the European Union; Permanent U.S. Representative to the Organization of American States (2); U.S. Representative on the Council of the International Civil Aviation Organization; Coordinator of U.S. Assistance for the New Independent States; Special Envoy and Representative of the Secretary of State for Holocaust Issues; Special Representative of the President for Nuclear Nonproliferation; Special Coordinator for Rwanda/Burundi; Special Negotiator for Nagorno-Karabakh and New Independent States Regional Conflicts (2); Special Envoy for Conventional Forces in Europe; Chief U.S. Delegate to the Joint Consultative Group (new position); U.S. Commissioner to the Standing Consultative Commission; Special Negotiator for Chemical and Biological Arms Control Issues; Coordinator of the Support for East European Democracy (SEED) Program; and Special Coordinator for Cyprus. Sixteen of these nominations were confirmed by the Senate.

There were 22 nominees to serve as United States representatives and alternates to the United Nations General Assembly and the General Conference of the International Atomic Energy Agency. Thirteen of these were confirmed by the Senate.

## E. MISCELLANEOUS ACTIVITIES

During the 106th Congress, the full Committee and its subcommittees held a total of 203 sessions. These included hearings on legislation, treaties, and nominations, as well as briefings and consultations with officials of the executive branch and non-govern-

ment witnesses on current foreign policy matters. Members and staff made individual trips abroad and participated in inter-parliamentary conferences to further exercise the legislative oversight responsibilities of the Committee. On 35 occasions, Members of the Committee received heads of state and senior officials of foreign governments to discuss matters of mutual interest.
